I. Course Description

This course is designed to introduce students to the mechanical aspects of agriculture. Primarily we use four stroke cycle engines, such as Kohler, Briggs and Stratton internal combustion engines. Students will learn skills in the following areas: safety, tool and equipment identification, small engines, and tractor operation and maintenance. Students will also complete advanced shop projects. Students will participate in FFA and record keeping. Students will be charged for any and all projects and materials they choose to take home. Grading Procedures

IV. FFA & SAE Responsibilities

The FFA portion of the grade is evaluated by participation in 3 FFA leadership development events per semester.

Additionally each student in Agriculture Education is required to take part in a Supervised Agricultural Experience (SAE). This is an agriculturally related project that nets at least 10 hours of work and the completion of the FFA Record Book. Raising an animal is not required. More information will be given to the students in class.

V. Class Rules

- 3. Non-class related items will be confiscated. Cell phones and other electronic devices are not to be seen or heard during class unless instructed by the teacher.
